

The members noted the Action Taken Report on the resolutions of the 19th meeting of the Academic Council.

FACULTY OF ENGINEERING

ITEM-3: Introduction of new credits division and credit share for preparation of course structure.

Dr. Ch. Vijay Sekhar: Respected Vice-Chancellor and members of the Academic Council, please permit me to move that the introduction of the following new credits division and credit share to be implemented during the preparation of course structure in the Faculty of Engineering, effective from 2021-22 academic year, as recommended by the BoS in Engineering be approved.

Suggestions:

Prof. N. Siva Prasad: (1) Suggested a detailed discussion on each category of the proposed course structure. For example: Under the "University core" category, what courses are offered and to what extent are they relevant to all undergraduate students across various faculties. Therefore, the commonality of the courses offered in this category should be discussed thoroughly before accepting the proposed structure.

(2) Suggested incorporating course category under course classification to align with the AICTE model curriculum.

(3) Advised a detailed discussion on the course classification, credit allocation, and credit distribution. The courses to be offered under each classification, along with credits, are to be presented for discussion.

Prof. D. Sambasiva Rao: Recommended the proposed course structure and found it to be a good initiative towards imparting knowledge on multiple disciplines, rather than having more profound knowledge in one area and stated it is in line with the recommendations of the National Education Policy (NEP). Further, hesuggested a detailed presentation on course structure, course classification, course contents and credits, which would be helpful for further discussions in the next academic council.

Prof. N. Seetharamaiah: (1)Brought to the Council's noticethat a new course entitled "Universal Human values" with three credits has to be included in the curriculum as per the AICTE guidelines which is out the existing 160 credits.

(2) AICTE suggested 20 credits for a minor programme which is out of the existing 160/163 credits.

Prof. Jayasankar Variyar: Informed the Council that the course "Universal Human values" is a part of the curriculum and included under the "Faculty Core" category.

Prof. VVV Nagendra Rao: (1) Suggested that under the "University core" category, courses from different disciplines are to be included rather than laying more emphasis on Engineering courses. (2) Further, he mentioned that the course structure related to the minor programmehas to be designed so that the students belonging to one discipline should opt for a minor programme in another discipline instead of opting for a minor programme within the same faculty.

Prof. Unnat P Pandit: Brought to the Council's notice that AICTE emphasizes the inclusion of a new course entitled "Intellectual property rights" in UG, PG and Ph.D. programmes and can be included in the curriculum as an optional course.

Dr. Bhoop Singh: (1) Suggested inclusion of a course with 1 or 2 credits toaddress the societal/local issues enabling social responsibility among the students.

(2) Suggested that the curriculum should be dynamic and revised regularly to match the market trend to improve the students' job opportunities.

Prof. Jayasankar Variyar: Brought to the Council's notice about the introduction of "Community Service" course with 2 credits, across various faculties under the "University Core" category.

Prof. Sundararajan: Recommended the new course structure and credit division proposed in the academic council as a positive step in curriculum design. He mentioned that the combination of

major and minor programmes will be beneficial to the students.

Prof. K. Siva Rama Krishna: (1) After due deliberations, suggested a change in titles of course category and course classification to be in line with the AICTE structure. Further, he suggested that the titles of courses category should be self-explanatory to all the university stakeholders.

(2) If possible, design the course curriculum so that the student can opt for a minor programme within the 163 credits by choosing open elective courses relevant to the minor programme.

(3) Design the course curriculum so that the quick learners can be awarded another minor degree by earning extra 20 credits within the programme duration.

The motion was put to the meeting and declared *deferred*.
