GITAM has a well-defined admissions policy where the process for admissions for the new academic year, the admissions committee headed by the admissions chairperson periodically conducts review meetings and monitors the application rate, entry rate, withdrawal rate for the underrepresented groups.


GITAM tracks the Women, Scheduled Caste (SC), Scheduled Tribe (ST) and Other Backward Caste (OBC) application rate and entry rate under different disciplines. It has MOUs with various organisations who conduct national level entrance examinations and collects the details of the number of students appeared for different national level test who are interested in pursuing a specific discipline. For example, The **Common Law Admission Test (CLAT)** is a centralized national-level entrance test for admission to undergraduate Law programs. **National Aptitude Test in Architecture (NATA)** is for admission into Architecture program.

Actions taken to increase the admission of underrepresented groups:


- ☞ Constitution 124th Amendment Bill, 2019 provides ten per cent reservation to the economically weaker sections (EWS) in the General category. The bill facilitates reservation for EWS in direct recruitments in jobs and admission in higher educational institutions. In the AY 2022-23, in GITAM, out of total National students 25492, 6.75 % are from Economically Weaker Section (EWS) in GITAM. It provides scholarships for these students and extends support for achieving their goals.

- ☞ GITAM scholarship policies also encourages the admission of the students from these underrepresented groups.
- ☞ It acts as a facilitator for students to get the national scholarships and state government scholarships for the deserved students.
- ☞ A scheme known as PMSSS to assist the students from Jammu & Kashmir to continue their education by providing the financial support.
- ☞ GITAM also Tracks the women application status to ensure that it will provide more admissions to women students.
- ☞ GITAM has dedicated committee and contact number to assist women students.



1. The sanctioned amount is debit-able to the major Head - 601.24 - 601.24.a(General)/ 601.24.b(SC)/601.24.c(ST) - Prime Minister Special Scholarship Scheme for J&K students and is valid for payment for disbursement to 4 Students of GITAM Institute of Nursing(44581), GITAM Institute of Nursing, GITAM Deemed to be University, Gandhi Nagar Campus, Rushikonda, Visakhapatnam - 530045.,Andhra Pradesh during the financial year 2024-25.
2. The amount of scholarship shall be drawn by the Drawing and Disbursing Officer (DDO), All India Council for Technical Education, New Delhi, on the Grants-in-aid bill and shall be disbursed to and credited to the account of 4 (four) Students for Special scholarship scheme for J&K students as per enclosed list (Annexure-'A') through DBT and to GITAM Institute of Nursing(44581), GITAM Institute of Nursing, GITAM Deemed to be University, Gandhi Nagar Campus, Rushikonda, Visakhapatnam - 530045.,Andhra Pradesh as per Mandate and enclosed list (Annexure 'B') through RTGS.
3. The scholarship (Academic fee as per Annexure 'B') is subject to the adjustment on the basis of Utilization Certificate in the prescribed proforma (Annexure II & III) submitted by the University/College/Institute. Further the accounts of the Institute will be open for test check by the Council or Comptroller and Auditor General of India or by any officer designated by them.
4. The University/College/Institute shall maintain a separate Bank account. The institute shall further maintain a proper account of the expenditure out of the scholarship amount.
5. The Utilization Certificate supported by audited statement of expenditure to the effect that scholarship has been utilized for the purpose for which it has been sanctioned shall be furnished to the Director(PMSSS), AICTE, Nelson Mandela Marg, Vasant Kunj, New Delhi - 110070, within a period of one month from the date of receipt of money.
6. That the institution has made actual verification of period of study and attendance of the J&K students and having met all the eligibility criteria. Institute will intimate AICTE in case any student leaves the Institute mid-way and would not claim any component of this scholarship from that day onwards and also that any component of the scholarship, if paid in advance, would be refunded by the Institute to AICTE on pro-rata basis.
7. The scholarship amount should be paid only to eligible student who fulfills the eligible criteria under the Special Scholarship Scheme for J&K Students as mentioned in the MHRD guidelines for the academic year 2023-24 as per the list placed at Annexure-B.
8. The sanction is issued in exercise of the power delegated to the competent authority. It is also certified that this grant-in-aid it is being sanctioned in conformity with the rules and principles of the schemes.
9. Required fund to the extent is available under the scheme.
10. This grant shall be used only for the purpose of disbursing scholarship to the students where no other financial assistance is received from any other agency.

Need based Scholarship

- Admitted candidates whose family income is less than Rs.12.00 LPA are eligible for Need Based Scholarship(NBS).
- For the award of Need Based Scholarship(NBS), student needs to upload the Form-16/ Acknowledgement of IT Return for the respective financial year of their father and mother in the counselling portal.
- Upon successful verification, the scholarship will be upscaled from 75% to 100%, 50% to 75%, 25% to 50% and 15% to 25% accordingly.

What Is the special fee at GITAM (Deemed to be University)?



Merit scholarships: The scholarship offered through GBAT/ GAT / National / State Entrance Tests only applies for the First Year. The same scholarship will be continued in the subsequent years of study, subject to scoring a CGPA of 8.0 or above. The student will be eligible for the scholarship in the year in which he fulfills the scoring of the required CGPA in any particular year in their course of study.

Need-based scholarships: The courses offered across campuses will be divided into two tiers,

a) Tier A : Tuition Fee \geq 2.00 LPA

b) Tier B : Tuition Fee $<$ 2.00 LPA

To be eligible for the need-based scholarship, the combined income of both parents/guardians of the eligible student/If the student is married, the combined income of the family, i.e., the student's and spouse's income, must be as given below

a) Tier A : Less than 12.00 LPA

b) Tier B : Less than 08.00 LPA

Employee children scholarships: The children of GITAM employees admitted in full-time courses who have secured 100% and 75% of scholarships are not eligible for employee's children scholarships. The children of GITAM employees admitted in full-time courses can avail 60%, 40%, 25%, and 15% of scholarships, not exceeding a total combined scholarship of 75%. The children of GITAM employees admitted are eligible for loyalty scholarships, and total scholarships should not exceed 75%.

Loyalty scholarships: The students admitted are further eligible for loyalty scholarships like alumni returning to higher education, alumni children, sibling scholarship, retired employee children scholarship, and spouse of GITAM employee.





GITAM Deemed to be University

GITAM being a Category I Deemed to be University and has a National character, practice equal access and promotes Women participation to greater extent. Because of the consistent measures and efficient tracking mechanism, it has ensured the increase in Women Student Applications and the current women student strength in the campus is around 35% Though Merit alone is the criteria for all the schemes, conscious efforts are made by GITAM to ensure the participation of Women Gender in reasonably good proportion. In order to attract women candidates, the entire campus has been provided with high tech Surveillance system, exclusive Women Amenities Centre, exclusive women security staff in the Student hostels etc., The percentage of acceptance of women candidates for higher education is relatively higher (more than 85%).
