Research Project to evaluate the PM Mudra Yojana program to contribute for meaningful insights to policy development.

Dr. Radha Raghuramapatruni, Associate Professor at GITAM School of Business, has secured a research grant of INR 13.0 lakhs from the Indian Council of Social Science Research (ICSSR), New Delhi. This grant has been awarded in support of her comprehensive research project, which aims to evaluate the impact of the Pradhan Mantri Mudra Yojana (PM Mudra Yojana), (a scheme intended to facilitate the micro loans to start income generating activities to come out of poverty), on women entrepreneurs in North Coastal Andhra Pradesh. This empirical study holds the promise of illuminating the effectiveness of the PM Mudra Yojana in empowering women entrepreneurs, stimulating economic growth, and fostering self-reliance among its beneficiaries and contributing meaningful insights to policy development.

KSPP Capstone Projects on Poverty

 "Asset Formation as an Instrument of Poverty Alleviation": This exploratory research by Archana Gupta explores poverty in India through an asset creation and ownership approach. It studies how the status of household-level assets corresponds to poverty rates and suggests broadening the idea of poverty mitigation beyond just income/consumption to include physical assets as an indicator of alleviation.

vulnerabilities of landless farming households in India and the inadequacies of existing social
protection systems. The paper suggests a targeted and unconditional cash transfer for

from a systematic literature review.
